GP-CPCS

Mike Jones, GP-CPCS Implementation and Support Officer

- Update on work so far – presentation given to members

There have now been 353 referrals = 128% increase.

Service is paying for work already done via walk-ins re MAS.

Linking the extended care services works better.

Pre - Engagement – talk through the way that the patient is sent back to the GP (wording needs to be passed back rather than referred or bounced back). Need to have a process in place.

Referring back and handing over care – legal obligation.

Need to look at the negative experiences and see how this can be changed for the next patient.

Have a beacon site (Manor Surgery) – rolling out over the whole of Nottingham West now.

NHSE are funding Implementation Officers across the whole of the Midlands – funding per ICS

Pharmacies are registered for services but are saying that they do not want to provide – various different reasons given.

Problem where some pharmacies are not signed up for CPCS service so not receiving referrals from NHS111 either – been talking to these pharmacies and explaining the direction of travel for future services.

All team members of the pharmacy need to be aware of the service so that when locums are working the pharmacy staff are still aware of the process and flag any referrals received to the pharmacist.

There is funding from NHS IT to make referrals simpler – integrated into systems.

PCN clinical pharmacists are actually helping with the roll out of this across all surgeries in their PCNs.

GP's will be targeted to provide GP-CPCS from Quarter 1 next year through IIF scheme.

GP contract in 2022/23 introducing a patient surgery score – this will be useful for the service

Extended Care

Main focus is on the UTI and Conjunctivitis PGDs at the moment.
