CPE UPDATE

Update from last CPE meeting – Attachment A

Contract / funding for 2025/26

CPE are not calling it negotiations - wording in the regulations is "consultation".

Civil servants are the same even though the government has changed so still have the relationship and background knowledge.

Hoping that will have something to report in the next few weeks.

Members asked what was the level of confidence in a favourable outcome? - Politically Wes Streeting and Stephen Kinnock have said that they are aware of the funding problems. Will be some uplift but not sure how much and if enough.

MP lobbying - really good re MPs asking parliamentary questions at the moment.

GP's have had contract imposed – possibility that this could happen again to pharmacy.



Pharmacy First

Advertising for PF – CPE were not consulted on before DHSC / NHSE sent out the adverts even though asked to be involved.

Lindsey will ask Alastair what has been said / asked re the advertising again.

Asking Alastair what support is being given for contractors re BP and contraception being added into PF and targets etc.

Hub and spoke visit helped see how things could work in the future.

NH speaks to CPE staff on a weekly basis – doesn't use the service database at the moment as not talking about new services. Mainly pushing BP, Contraception and PF and using pharmacy.

Update on TAPR actions

Held one forum of chairs so far- will review and see how it is working and future discussions.

Regional meeting with CPE on 29th January 2025 being held at the CPN office.

Need to change the constitution because changes to membership are taking place so will be information being sent out as both CPE and LPCs will need to change and hold contractor meetings.

2 x Observers been selected to attend the CPE meetings and local LPCs are invited to the CPE meetings when held in their region.

Mike Jones, Service Implementation Lead

Services update

Pharmacy First

Discussion on how things went over Christmas.

One of the main things that Mike highlights when presenting is the inclusion / exclusion document as helps with the number of bounced back referrals.

Signposting is part of care-navigation which has been built into the GP process for many years and so hard to change as completely opposite to referrals.

BH direction – need to focus on what services were utilised. Also need to look at whether should open longer on BH to cover for GPs being closed and NHS 111 referrals.

November - only 83 out of 216 met threshold.

Only 39% met threshold for November and thresholds increase for January, February and March! Ask for feedback from contractors what they are focusing on and insights into why the numbers are low at the moment – is it to do with concentrating on Flu / Covid???

Action: Newsletter article highlighting that patients can access through NHS 111 online and NHS app

Contraception Service

Sent out the letters to pharmacies explaining the service and importance of signing up now as will be linked to the PF service from April 2025 and moved from 75 signed up to 111 – thanked the LPC for allowing to send throughout via post re postage and work expense.

Still have more to do especially on initiation as very low nationally as well as locally.

Link to the EHC service and other sexual health services would be the ideal situation – MJ has been talking with Matt Osbourne, Public Health Nottinghamshire County Council around future service as they have just gone through a major change and wishing to link to existing pharmacy services available too on the new sexual health website.

Flu / covid vaccinations

Not many pharmacies have vaccines left but Sequiris have said that they have supply available – not sure of the costs etc.

AE has been in contact with CGL and they have an update on the contract and fees – ask them to come to the meeting in March 2025.

OPEN MEETING



Dr Dave Briggs, Medical Director, Nottingham and Nottinghamshire ICB

Quarter 4 – hard month to land anything financial but will feedback. Importance of transformation:

- Frailty and long-term conditions

Want pharmacy to be involved in the neighbourhoods. Will share plans for the neighbourhoods when able – will have a place around the table re planning. Could be opportunity for future IP work.

National? model – Dave Briggs has written to express that community pharmacy should be involved. Poly Pharmacy review – using Medicines Optimisation Strategy which includes community pharmacy

- This could be done with a change to contracting pharmaceutical services.

- Maybe have some pilot sites – new model of working – LPC to help choose areas and pharmacies. How do 'we' personalise care - only acute care. Need to have a consistent approach and have community pharmacy input.

Outpatients - need to reduce follow ups so have capacity for new referrals.

27/01/25 - will share transformation plans.

Members reported that pharmacies are seeing less requests for end-of-life medication packs.

End of Life service in Notts is a stock holding service and is being reviewed at present – Dave Briggs asked if this could be included as part of the Pharmacy First Service.

Long term condition management – are we going to lead or follow – Dave prefers to lead and develop. 56-64 year old mortality rate regarding CVD is coming down – helped by the Community Pharmacy Hypertension service – this should be a good news story and will work with Dave for an article in the newsletter and on social media.

Dave asked what 3 things would community pharmacy wish him to pass onto others higher up including Clare Fuller, Director of NHS Primary Care nationally.

- IT / Info sharing problems wish to look at this prior to having a problem.
- Work on local and then push up nationally rather than the other way round
- INW sites not involved community pharmacy Dave said this can be changed immediately
- CP being able to refer onto right specialists / not aware of services in the area.

Need to think through media campaigns and target where needed.

There was previously always one person with Pharmacy First on their role / portfolio – transformation managers have now been tasked with this.

Modern GP's – includes triaging but not doing.

Things that Rebecca has noted from conversations

- Contractors are unaware that they can refer
- Communication problems between contractor and staff
- Refuse to check emails
- Problem with cap of 10 NHS.net emails per pharmacy if staff leave then cannot take off the total email number
- Press articles lined up with local pharmacies.

 Emma Marsden, Well in Bassetlaw send details to Rebecca
