- Proposed Constitutional Changes Seeking views from LPCs

 We have now begun the process of seeking views on these proposed changes from the LPC network and the sector bodies (CCA, IPA, NPA). It is proposed that these changes will be made from September 2025, effective for elections beginning in October 2026, and new terms of office starting in April 2027. A more detailed timeline is attached we will want to talk further with you on the practicalities, such as aligning special meetings with LPC AGMs, and of course will nearer the time support with necessary templates and other documentation.

Members discussed the proposal and all expressed their views, there was general agreement on keeping the 50/50 split between independents and multiples. Members had varying opinions regarding how the



multiple make up should be split and this included what number of contracts indicates it as a multiple. There were some questions asked around member lists and that it is sometimes hard for LPCs to know which trade body a pharmacy contractor was a member of. Agreed that members can reply as individuals and that following any further feedback a response will be sent explaining the committees differing views.

2 - CPE UPDATE

Update from last CPE meeting – Attachment 2A

Key points from the regional reps report:

CAPS on PF and NMS and need to ensure contractors know about this – suggested its added to newsletter in May 2025.

CAPS have been quarterly reviewed and now being planned to move to a monthly review.

CPE CPCF Implementation working group

Still some timelines that need to be added in on the CPCF and PQS - working on this still

Contractors did not understand margin and how it gets paid was a key learning from when they attended the roadshows. NH also reported this from when he talks with contractors. CPE have produced a Margin explainer – asked for feedback – ask new contractors if they understand how, it works and it this helps.

NMS subcontracting- CPE regional rep updated the committee on the changes to the NMS payment structure .

CPE report a varying degree of responses – ask is that LPCs encourage contractors to answer – difficult for CPE to use feedback if only a small number of responses

Lots of questions are being asked by MPs in parliament – still need to try and encourage more MPs to do this

Questions / comments from members

APBM per month to get threshold payment, members expressed that they are worried that some contractors will not achieve this – number of over 40's that have not had a BP check is running out and so less opportunity for appropriate BP checks and therefore less ABPM.

Some pharmacies have been doing lots of BP checks and no ABPM so there is a need to ensure that both parts of the service are being completed, members asked how CPE/NHS can support ensuring quality delivery of the service.

Regarding ABPM members raised that some GPs prefer to have 7 days of readings – asking if this can be added into the contract

Integrated neighbourhoods

CPE have undertaken a survey of LPCs and are planning further support.

EHC in Contraception October 2025

Members asked if there will be any national promotion of this service?? LF will feed into the implementation working group

Caps for PF

Members highlighted possible concerns with PF caps and would like to know how often the caps are reviewed and how they are worked out?? Maximum cap is 135 at the moment.

 Looked at those that are just 5 gateway consultations under the threshold targets MJ rang them (20 pharmacies)
 - Highlighted the service and how to claim etc
 - Hints and tips Stickers on items to remind staff to refer into the PF consultation

91 contractors did not hit target for last three months – less than previous month – so improving.

Contraception Service

Focused on those that have not signed up - only 20 - will be contacting them to say that if don't sign up by end of August then will lose the £900 training fee.
