Welcome and introductions

Welcome and Introductions were given to guests in the afternoon session.

1 - CPE UPDATE

Lindsey Fairbrother, CPE Regional Representative
 CPE update – Attachment 1A

Projects currently working on

Need to start work on negotiations asap – Autumn – need to get this done so that can have time to look at changes and training needed ready for April 2026.

PA consulting are helping with negotiating

- looking at the contract
- margins,
- payment,
- scrapping of prescription charge etc,

Looked at different models as if starting from nothing.

Implications of funding settlement on sector

- 1 retained margin
- 2 evaluating contract

Flexibility around dispensing – pharmacists should be able to change prescriptions – unless under SSP. Rules are not helping at the moment.

Engagement with pharmacies

Sector polling – contractors are members of public and ministers listen to public opinion.

RS asked LF if could get local data to see who has responded so LPCs can chase up – newsletter article to explain how important it is to complete

More positive on last poll but 94% are looking at using the new regulation to be able to reduce hours.

Sub committees

Draft versions for PCS – been agreed but with NHSE for sign off!! Draft PF PGDs with new gateways are now available

Capping - this was to ensure that all contractors were able to have access to the funding available rather than some doing 1000s and taking all the funding

Legislation and Regs

Hub and spoke – need to inform the ICB if using and CPE are trying to ensure that it is a simple form that contractors need to complete. Also need to look at what happens if the hub goes wrong and contingency plans

Regulation proposals – making COO easier

Need to give feedback - what would make life easier? - send to CPE

Constitution – appointed an independent expert to look at the changes

Feedback to CPE via Lindsey

- Referrals for PF working hard but not getting anywhere only 40% on Healthwatch survey had heard about PF, only 9% from local pharmacy and 7% from GP. Need to get information to the public.
- Is there going to be an overlap of old PGDs and new PGDs starting LF advised to get teams aware of the new gateway as do not feel there will be any changes to them before publication.
- More clinical services no resources for this training GPs get PLT know need to be more skilled but do not get any support for being able to train.
- IP's need to be kept up to date with CPD. maybe need to talk about patient safety aspect

Bundling – 38% nationally have not signed up to PF and Hypertension service

Only 6 Nottinghamshire pharmacies have not signed up if don't include the DSPs



Working on sending out comms to those that have not done this so far – also sending out comms re not doing ABPM so not getting threshold payment

PF and PCS need to be signed up for by 31st August to meet PQS gateway – reminders have been included in the newsletter and sent out individual emails.

Harts Pharmacy – attended Healthy Heart event in Hucknall – BP checks done by PCN pharmacists – then sent through ABPM to Harts Pharmacy stand and made appointments to have these done. Had 7 referrals sent across. Really good event.

Nottingham City event - Nishant Patel, Vantage Pharmacy attended

As a contractor not useful – but need to be involved as an LPC Contact with Talking Therapies – patients can self-refer - they are happy to attend and talk about the service – link to the NMS service adding in antidepressant medication starting in October – leaflets available, Podcast recording etc – MJ will contact them and invite to attend the next committee meeting.

Integrated neighbourhoods

What do we need to do to get pharmacy integrated into the neighbourhood plans?

Frailty and poly pharmacy are the main items being discussed.

- Will they have commissioning ability??
- Looking at where spend time
- Notts have a timeline change in ICB, set up MDTs,
- Place level is important level rather than down to PCN level
- Locally need to have GPs, Pharmacies, Optometry etc involved and build relationships

Need to know the tangible benefit / outcome for contractors and need the funding for pharmacies to be able to attend the meetings

In Derbyshire neighbourhood discussions are being done collectively and only at GP level – meeting happened and excluded dental, optometry and pharmacy and the chief pharmacist at ICB was not even aware.

Nottinghamshire are being inclusive and MJ is attending as many meetings as he can – helps that have a good relationship with Rachel Rees who is leading on the neighbourhood / PCN work
